

Hint

- Calculate simple interest, use the formula $I = Prt$.
- Calculate compounded interest, use the formula $A = P(1+r)^t$.
- I = the interest earned
- P = the original principal amount.
- r = percentage rate converted to a decimal
- t = time in years
- A = accrued total in principal amount and interest earned
