Compound interest is the interest paid or computed on both the original principle and on the interest it has already accrued or earned. To calculate compound interest, use the following formula, Amount $=\operatorname{Principal}(1+\text { rate })^{\text {time }}$ or $A=P(1+r)^{t}$
